## RULES AND FEES

**Art. 1) ITABIA Italian Biomass Association** Association (hereinafter referred to as the “Organizer”), in collaboration with **CNR IBE** (National Research Council - Institute for Bioeconomy) and **FEDERUNACOMA** (National Federation of Agricultural Machinery Manufacturers) organizes the Futa Expò field event - a live demonstration and commercial event dedicated to technologies and equipment for the forest and wood industry. The event will take place from **4 to 6 July 2025** at La Dogana farm, in Barberino del Mugello (FI).

**Art. 2)** All companies that manufacture, adapt, market or promote technologies for forestry and wood processing are admitted to the event, including those who deal with:

- forestry tractors
- silviculture machinery and equipment
- components and separate parts of tractors and forestry machinery
- accessories, tools, clothing, etc.
- services for forestry companies and operators (financial, insurance, rental, specialized and sector press)

**Art. 3)** Stand allocation is the exclusive responsibility of the Organizer and will be communicated to **FUTA Expo** participants 30 days before the start of the event.

**Art. 4)** Exhibitors may take possession of their stands starting from 9:00 on July 1st; they finish setting up their stands by 20:00 on July 3rd. Dismantling of stands may begin at 18:00 on July 6th. All companies must vacate their plots by 18:00 on July 8th.

**Art. 5)** Stands will be set up by the exhibitors as desired, provided that compliance with the current provisions of the law is assured. The display of advertisements, panels, banners etc. is permitted exclusively within the exhibitors' own stands. The Organizer will make available to each exhibitor the type and amount of biomass necessary for carrying out the demonstrations. Exhibitors waiving that service are not entitled to any reimbursements, except for specific agreements to be defined on a case-by-case basis and which do not bind the Organizer in any way.

**Art. 6)** The exhibitors exonerate the Organizer from any civil and criminal liability, for anything that may happen inside their stands from the moment of delivery until its return.

**Art. 7)** The demonstrations must be carried out by qualified personnel, capable to safely use the machines and equipped with all the PPE required by law. Exhibitors who allow visitors to try their machines will do so under their own responsibility.

**Art. 8)** The Organizer is not responsible for machines that do not comply with the current regulations on machine safety and accident prevention. Please remember that the machines referred to in Art. 1 must comply with the European work safety regulations.

**Art. 9)** Exhibitors are required to acquire a suitable and comprehensive insurance policy for the event (damage and personal liability, transport, theft, fire, exceptional events). The exhibitor assumes full responsibility for any damage or theft that may occur during the event or during the set-up and dismantling period.

**Art. 10)** If the date of the event is changed or the event is cancelled due to Force Majeure or for reasons beyond the control of the Organizer, no compensation is granted to the exhibitors.

**Art.11)** The accompanying documents for any travelling goods (tractors and equipment) must be addressed to the exhibitors themselves, with destination "Azienda Agricola La Dogana - Località La Dogana - 50031 Barberino di Mugello (FI)."

**Art. 12)** The trucks must be parked in the parking spaces set up for this purpose and properly indicated by the Organizer.

**Art. 13)** The following will be the responsibility of the Organizer:

- Arrangement of plots/signage
- Organization of exhibitor and visitor parking
- Night surveillance
- Various services (first aid, fire services, toilets)
- Basic liability insurance

**Art. 14)** To reach their own stands with their machines, equipment and materials, exhibitors must follow the route marked for that purpose. The stands must be set within the perimeter assigned, without invading any visitor and/or emergency paths.

**Art. 15)** Admission to the event takes place upon presentation of the request for participation, drawn up as communicated by the Organization in the participation forms. The Organizer reserves the right to confirm admission to the event, as well as acceptance of the machines to be exhibited.

**Art. 16)** Participation fees are reported in the table right below and vary according to the space required by the exhibitors who will be able to benefit from a 20% Early Bird discount if they pay the balance by 15 March 2025.

**Art. 17)** Admission is subject to payment of the total amount including VAT within the deadline indicated on the application form.

**Art. 18)** The Organizer reserves the right to establish additional rules and provisions deemed appropriate to improve the safety and efficiency of the event, even in derogation of this regulation.

**Art. 19)** By signing the application for admission, the exhibitors accept the general regulation and all supplementary provisions that will be adopted by the Organizer. Furthermore, pursuant to law 675/96 and subsequent additions and modifications, the use of data for purposes functional to the development of the event is authorized. Information to the interested party pursuant to art. 13 of legislative decree no. 196/2003 and provision of consent. The personal data provided by the interested party are also processed with IT tools for the purposes indicated in this regulation and in the application forms in order to pursue the institutional purposes and any other activity - even if connected or complementary - aimed at promoting the exchange of goods and services, including the activities necessary for the ordinary management of the exhibition, online and offline publication, evaluation of user satisfaction, commercial and marketing purposes, statistical purposes and other similar purposes that may involve the communication and dissemination of data to third parties, operating in Italy and/or abroad. Specific security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access, in compliance with the provisions of Legislative Decree 30/06/2003 n. 196 articles 31-33-34-36. Data processing maybe conducted directly or with the intervention of third parties, and data may be used, communicated and transferred to third parties - even outside the national territory for any initiative connected or consequent to the exhibition or aimed at promoting the exchange of goods and services object of the initiative itself - and in particular to those who collaborate in any form in the implementation of the Organizer's activities, as well as to other subjects in the trade fair sector or who operate in the sector itself (associative or consortium bodies - external databases - market research - etc.) - and to those interested in the economic sectors inherent to the exhibition.

The data controller is the Organizer.
